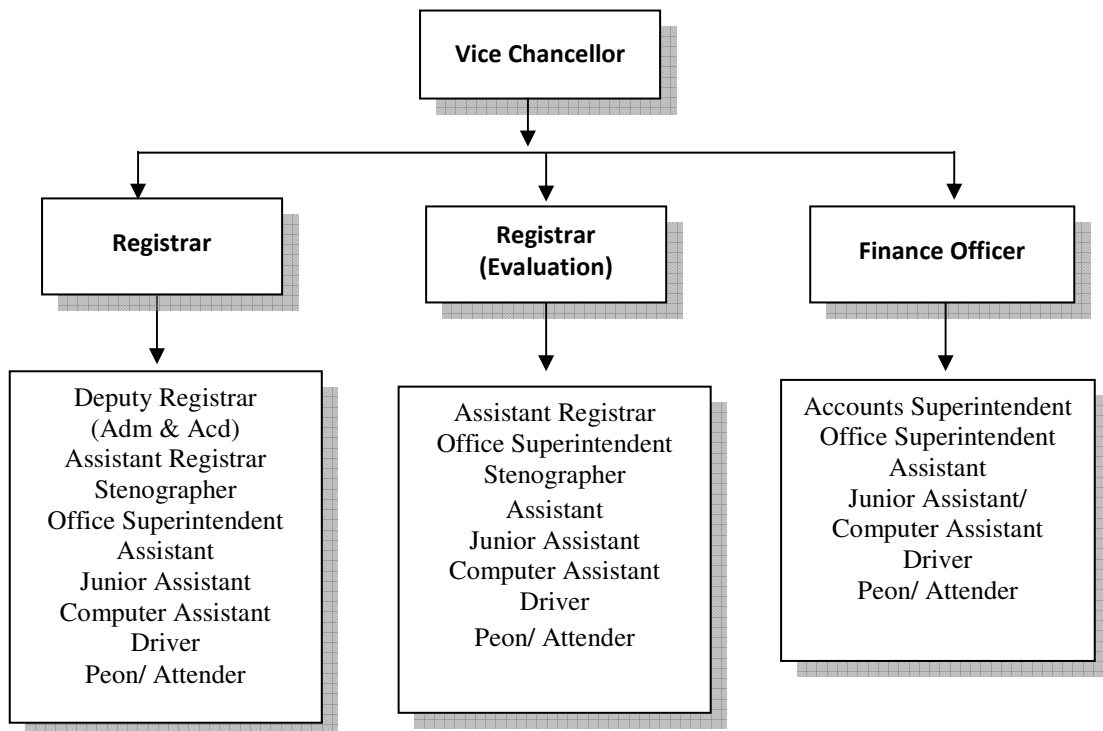
Template No. I: Particulars of the organization, functions and duties

Name of the Organization

- 1) Karnataka State Law University has been established by the Government of Karnataka under the Karnataka State Law University Act, 2009.

The University came into being on 01.01.2009 and commissioned its service since then. The University is on a sprawling 54.11 acres of land, Hubballi-Dharwad Corporation main road (N H -4), close to Office of Commissioner, Regional Road Transport. Navanagar, Hubballi -580 025.
