## NOTIFICATION

**Sub:** Provisional registration of Examination Application Forms for 3 Year LL.B., 5 Year B.A., LL.B. , B.A.,LL.B.(Hon's.), B.B.A., LL.B., B.B.A., LL.B. (Hon's.) and LL.M.(2 years) Examinations for regular and repeaters batch students to be held during **December 2015**.

Karnataka State Law University proposes to conduct Examinations for students admitted during 2015-16 and for repeaters students of various semesters **from 21.12.2015**. The following information is provided for the Notice of all students and staff of all affiliated colleges of Karnataka State Law University, on present fees structure prescribed, last dates of filling examination applications and submitting them to University, and commencement of Examinations. Students are required to fill **fresh subjects in one application and for repeaters all subjects in one application separately**, along with requisite fees payable. The instructions from 1 to 8 are to be carefully followed along with Mandatory instructions.

**Note:** \* indicates that particular fee is not applicable to candidates under SC/ST/ Category – I with annual income of not more than Rs.2,50,000 /- for taking Examination as **Fresher's / Repeaters.**

## **SPECIAL INSTRUCTIONS**

1. The acceptance and registration of applications for the examinations is Provisional. Admission to examination is subject to students, fulfilling all other criteria prescribed including eligibility and attendance. Therefore, after the last working day principals are advised to intimate fulfillment of attendance requirements of their students in the enclosed proforma compulsorily.
2. Principals are informed to ensure that a DD (**in favor of FINANCE OFFICER, Karnataka State Law University, Hubli**) is drawn on the very next (bank) working day, of any particular last date prescribed for entire corresponding amount collected by them. However the details of such students be e-mailed to [regevakslu@gmail.com](mailto:regevakslu@gmail.com) on same day (last date) before 5.30 Pm.
3. Students are required to remit Examination Form Fees (Rs.80/-) and Marks Card Fees (Rs.135/-) in addition to applicable Examination Fees.
4. In accordance with Notification issued by Commissioner of Backward Welfare Department of Karnataka State (Notification No.397/2013 dated 05.09.2013), among all the candidates coming under SC, ST, Category – I and only those coming under Categories 2(A), 2(B), 3(A), 3(B) **with annual income of not more than Rs.1,00,000/-** are exempted from paying Examination Fees. But these candidates must remit Examination Form Fees (Rs.80/-) and Marks Card Fees (Rs.135/-). Further, Principals have to furnish this information to State Government within 10 days, and follow up the issue with said department, in getting exempted fees reimbursed and such amount be remitted to KSLU, Hubli within 3 days from reimbursement from State Government.
5. (i) All computerized applications for above mentioned course/semesters for Fresher's and Repeaters will be printed and sent by University Examinations office. For Fresh candidates admitted for 1<sup>st</sup> semester (For the Academic year 2015 -16) OMR forms to be supplied. Colleges are advised to distribute the examination application forms by collecting Rs.80/- per application per semester, from students and amount so collected be remitted to KSLU in form of Demand Draft payable to Finance Officer, Karnataka State Law University and payable at State Bank of India (Branch Code 13201). The applications of all candidates complete with all details in enclosed proforma, be sent to KSLU, Hubli in time.  
(ii) It is to be noted that remitting fee and submitting examination application is **mandatory** for students seeking promotion to next academic year 2015-16 if eligible otherwise.  
(iii) All the fresh semester (studying in odd semesters) students are required to note that remittance of fee and submitting of examination applications do not guarantee rights to write the examination. In addition to other requirements, they are required to fulfill at least 70% class attendance to be held eligible for admission to examination.
6. For students belonging to Categories 2(A), 2(B), 3(A), 3(B) **with annual income of not more than Rs.1,00,000/-** exemption from remittance of Examination fee payable is available and extended to **Fresher's only** and not available for Repeater batch students. Consequently, **Repeater batch students are required to remit fee as applicable under Sl. No. 5.**

7. Application forms collected without penalty, with penalty of Rs.100/- and penalty of Rs.1,500/- should be sent in time as per notification and colleges are advised not to delay or seek acceptance of late applications. The heads of institutions are required to ensure that applicant students to fresh batch who fulfill attendance requirement of at least 70% only, are issued admission tickets for the examination.
8. The application with penalty of Rs.1500/- must reach on the Date/Day mentioned in this Notification or else it will be rejected.

### **MANDATORY INSTRUCTIONS**

- 1. It is mandatory for colleges to fill the Percentage of Attendance in case of fresh Candidates.**
- 2. If Attendance is not mentioned the Application will be rejected once for all.**
- 3. The Applications of such candidates should not be forwarded to University, who could not fulfill minimum 70% of ATTENDANCE.**
- 4. In case college forwards any such applications the principal will be solely responsible for future consequences.**
