**The following items were discussed and resolved as under:**

1. The Hon'ble Vice-Chancellor welcomed the Physical Education Directors of various Law Colleges and introduced Shri Khalid Khan, first Director of Physical Education, KSLU, to all the members present at the meeting.
2. The Hon'ble Vice-Chancellor introduced the Registrar (Evaluation), Prof. K.S.Bagale, before the commencement of the proceedings.
3. Bringing up the issue of the need of a Physical Education Director in various Colleges it is resolved that every college shall make arrangements to appoint a Physical Education Director, with a minimum qualification, of M.P.Ed, if they have not already done so.
4. Various questions were raised and after discussion it is resolved to take the following decisions in relation to the inter collegiate tournament it was resolved as under:
  - All the affiliated colleges shall be divided into four zones for sports meet as follows :  
Bengaluru, Mangalore, Hubli and Gulbarga.
  - The zonal in-charge for the sports for a period of one year will be as follows.
    - Gulbarga Zone            Shri K.P. Sawalmath, SSL Law College, Gulbarga
    - Bengaluru Zone        Shri Siddappa, MS Ramaiah Law College, Bengaluru.
    - Hubli Zone                Shri Khalid Khan, Karnataka State Law University, Hubli
    - Mangalore Zone        Shri Prakash, SDM Law College, Mangalore.
  - Each college must participate in at least 4 games.
  - There must be a minimum of 10 participants from every college for Athletics.
  - Only those students admitted to the affiliated law colleges, from the academic year 2009-10 onwards, shall be eligible to participate in the selections for **University Blue**; all other students with regular admissions irrespective of the year can participate in inter collegiate sports competition.
  - The selections may be held in the 1<sup>st</sup> week of November, 2010.
  - For the academic year 2010-11 however, only tournaments for Volleyball, Table Tennis, Badminton, Kabaddi, Basketball and Chess will be held in a single zone.
  - The athletic meet for the year 2010-11 will be conducted by the Karnataka State Law University, Hubli.
  - To hold a game/ Athletic a minimum of 10 teams must participate in each game.
  - The following games are selected by the Law Colleges for Inter Collegiate Tournament:

5. It is resolved to constitute a committee for sports as follows:

IV	Four Physical Education Directors of affiliated law colleges	Members
V	One Eminent Sports person from Karnataka	Members
VI	Director of Physical Education KSLU	Member Secretary

6. The Hon'ble Vice-Chancellor strongly suggested that compulsory Physical Fitness programs should be conducted for the students every day in each college.
7. It was resolved that KSLU must have a tie up with Sports Authority of India (SAI) and Karnatak University, Dharwad (KUD).
8. It is resolved that examination grace marks and grace attendance of 10-15% should be given to **University Blues**. (To be approved by Syndicate).
9. It is resolved to provide Shoes and Blazers with Emblems and logo to the coaches and Physical Education Directors who are invited by KSLU for University Blue Tournaments.

10. The color of the blazer will be decided by the sports advisory committee. (Which may preferable be sky blue/ Dark Green).
11. It is resolved that M.S.Ramaiah Law College, Bangalore will host the athletic meet for the academic year 2011-12.
12. It is resolved to observe the following formalities in the matter of the Inter Collegiate tournament:
  - i) The athletes must produce the Original/Attested SSLC Marks Card and the attestation should be done by the college Principal only.
  - ii) The coaching camp must be held for 10-12 days before sending the team to the Inter University tournament.
  - iii) The Syndicate approval must be taken for TA/DA for the Director of Physical Education, Manager, Athletes, coaches and selection Committee members for conducting camps, Inter Collegiate and inter university tournaments. The amount must be approved by the Sports advisory committee and then it must be sanctioned by the Syndicate.
  - iv) Every Law College must possess Minimum sports equipments.
  - v) The KSLU will provide the Gold, Silver and Bronze medals, trophies, certificates and officiating charges during the Inter Colligate tournament for the **academic year 2010-11**.
  - vi) A Sports link must be provided on the KSLU official website.
  - vii) No entry fee will be charged for any college for the Inter Colligate tournament and University blue selections for the **academic year 2010-11**.
  - viii) During every academic year the first meeting of Physical Education Directors **must** be convened in the month of June.
- . The meeting concluded with vote of thanks by Director of Physical Education, KSLU.
