**The following items were discussed and resolved as under:**

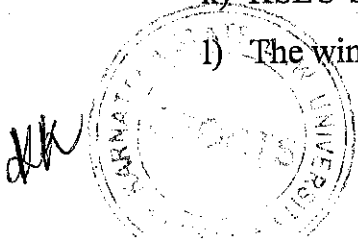
1. Confirmation of Proceedings of the Previous Meeting of Physical Education Director and Sports Advisory Committee Meeting held on 19<sup>th</sup> July 2012 .
2. It was resolved to send the following teams for Inter University Tournaments for the year 2013-14.

**3. POINT SYSTEM**

It was resolved to Change the Point System the following are the New Rules.

- a) Each team participating in Inter Collegiate Meet, Men and Women events will be awarded 10 points each.
- b) Winning Team in Inter Collegiate will get 20 points.
- c) Runners Team in Inter Collegiate will get 15 points.
- d) Third place in Inter Collegiate will get 10 points.
- e) Fourth place in Inter Collegiate will get 5 points.
- f) Phy. Edn. Director/Manager escorting the team will be awarded 10 points.
- g) University Blue per student will get 25 points each.
- h) Hosting selection trails will get 10 points. Only Inter Collegiate 15 points and Hosting both men and women will get 30 points.
- i) Attending the University selection trials will get 5 points per student.
- j) First to Three Cash Prize winners of last year will not get chance next year.
- k) KSLU's Law School, Navanagar, Hubli is exempted from the cash award.
- l) The winners will get sports materials.



4. It was resolved for 'Host Colleges' to provide with Rs. 150/- per head per day for a Student and Rs. 5,000/- for other expenditure to conduct Inter Collegiate Tournament.
5. It was resolved for hosting Cricket Inter Collegiate to provide with Rs. 150/- per head per day for a Student and Rs. 20,000/- for other Expenditure.
6. It was resolved that Cricket Selections will be held at KSLU, Hubli with Rs.1,000/- as entry Fees per College.
7. It was resolved to host a two days National Conference in Sports at KSLU.
8. It was resolved to give a Gold Medal for the best out going Sportsmen at Convocation Function.
9. It was resolved that each College should Participate in minimum two Inter Collegiate Tournaments.
10. It was resolved that Host College should arrange a Clinic in their respective games, Rs. 1,000/- Honorarium will be borne by KSLU.
11. It was resolved that summer Coaching Camp with selected Students for each College to be conducted at KSLU for 10 to 15 days.
12. It was resolved that maximum of 5 participants shall be allowed for selection trials from each college.
13. It was resolved that both Coach and Manager will be sent for inter University tournament.
14. It was resolved that M. S. Ramaiah Law College, Bangalore shall host the Inter Collegiate Athletic Meet 2013 during November 2013 at Bangalore. The Physical Education Director of the College requested for higher monetary support from University. He was directed to submit the detailed estimate and requirements to be approved by Sports Advisory Committee.
15. It was resolved that daily one period of Physical Education to be included in the time table .

#### **16. FACILITIES FOR UNIVERSITY BLUES**

- a) It was resolved to provide DA for University Blue and KSLU's Law School Students, Rs.500/- per day and for Coaches, Managers, Physical Education Directors, Selection Committee Members, Convener, Sports Advisory Committee Members, Director of sports etc., DA Rs. 1,000/- per day.



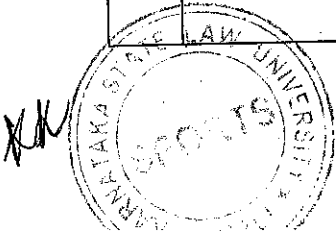
- b) It is discussed that examination grace marks should be given to **University Blues**. The Director of Sports, KSLU was asked to submit similar provisions of other Universities and submit to Registrar.
- c) It was resolved to send a detailed Annual Report of Sports to Director of Sports along with a detailed Bio-Data of Physical Education Director.

### 17. SPECIAL PRIZE MONEY

- a) It was resolved to provide the Winners of All India Inter University Competition such as 1<sup>st</sup> to 4<sup>th</sup> place, will get Cash Award of Rs. 25,000/- per student. 5<sup>th</sup> to 10<sup>th</sup> Place will get Cash Award of Rs. 15,000/- per student.
- b) It was resolved for team events securing 1<sup>st</sup> to 4<sup>th</sup> Place in South Zone Inter University Tournaments will be awarded with Rs. 1,00,000/-


- Hon'ble Vice-Chancellor expressed his views on Sports of KSLU.

- Miss. Vasavi Hegde KSLU's Law School Student proposed vote of thanks.


20. A Clinical Session was arranged for all the Physical Education Directors affiliated to KSLU.
