The following items were discussed and resolved as under:

1. Bringing up the issue of the need of a Physical Education Director in various Law Colleges, it is resolved that every college shall make arrangements to appoint a Physical Education Director.
2. Various questions were raised and after discussion it is resolved to conduct the following games in the host collages on the dates specified against them:

3. It was resolved that, Extra ordinary students in individual events such as swimming, shooting, weight lifting etc., will be called for selections at KSLU to select for University Blues.
4. It was resolved to send the following teams for Inter University Tournament for the year 2011-12
 - a. ATHLETICS
 - b. VOLLEYBALL
 - c. KABADDI
 - d. BADMINTON
 - e. TABLE TENNIS
 - f. CHESS
 - g. CROSS-COUNTRY
 - h. FOOTBALL

POINT SYSTEM

5. It was resolved to introduce points system to encourage more participation in Inter Collegiate Tournament. The following are the rules :
 - a. Each team participating in Inter Collegiate Meet, Men and Women events will be awarded 5 points each.
 - b. Winning Team in Inter Collegiate will get 10 points
 - c. Runners in Inter Collegiate will get 7 points
 - d. Third place in Inter Collegiate will get 5 points
 - e. Physical Education Director /Manager escorting the team will be awarded 5 points
 - f. University Blue per student will get 10 points each.
 - g. Hosting the Inter Collegiate Competition will get 10 points
 - h. Attending the University selection Trails will get 2 points per student.
 - i. First three Prize winners of 2011-12 will not get chance next year.
 - j. KSLU's Law School, Rayapur, Dharwad is exempted from this point system.
6. It was resolved to distribute sports equipments to the winners on point system.
 - a. First Place – 50,000 worth sports equipments
 - b. Second Place – 40,000 ”
 - c. Third Place – 30,000 ”
 - d. Fourth place - 20,000 ”
 - e. Fifth place - 15,000 ”
 - f. Sixth place - 10,000 ”
7. It was resolved that Students affiliated to KSLU only will be allowed to participate in Inter Collegiate Tournaments and University Blue Selections.

8. It was resolved that Principal of the host college will be the Chairman and Physical Education Director will be the convener for the Inter Collegiate Tournament.
9. It was resolved that Director of Sports of KSLU will be the Chairman and Principal of host college will be the convener for Selection of University Blue.
10. It was resolved to conduct coaching camp at KSLU campus Hubli for 8-15 day's.
11. It was resolved to invite Qualified coaches/experts for coaching camp.
12. It was resolved not to levy any entry fees for Inter Collegiate and University Blue Selections.
13. It was resolved that the host college will provide Food & Accommodation to all the participants.
14. It was resolved that Physical Education Director of the host college will be the manager for university team.
15. It was resolved that Medals, Trophy's and Certificates will be provided by KSLU for Inter Collegiate competition.

FACILITIES FOR UNIVERSITY BLUES

16. It was resolved to provide a pair of T-shirt, Shorts, Shoes and Track Suit from KSLU, Hubli.
17. It was resolved that Blazer will be provided to University Blues only once.
18. It was resolved to provide TA/DA for the participating students in sports, Train II class sleeper or Bus fare DA Rs. 250 per day and II AC Train fare for Coaches, Managers, Physical Education Directors and Selection Committee Members, DA Rs. 400 per day.
19. It was resolved that to give Grace Attendance to University Blues.
20. It was resolved to hold a function of University Blues at the end of the year to distribute blazers for University Blues.
21. It was resolved that from the next academic year sports development fees should raised to Rs. 200 per student and sports fee to Rs. 100.
22. It was resolved to send a detailed Annual Report of Sports within one week to Director of Sports along with a detailed Bio-Data of Physical Education Director.
23. The Hon'ble Vice-Chancellor stressed on encouraging the students to participate in sports activates so as to build up strong willpower in the student community.
24. It is resolved that examination grace marks of 10-15% should be given to **University Blues**. (Subject to the approval of Government).
25. It is resolved to cover life of Sports persons along with Team Manager/ Coach with insurance.
26. Parents willingness letter to be obtained for participating in Sports.

 3. It was resolved that Rs. 10,000 to 15,000 each be given to the host College to conduct Inter Collegiate and selections trails according to the no. of participating teams, event wise.
 4. It was resolved that Athletic Meet to be held in the month of October -2011 on the campus of KSLU, Hubli.
 5. It was resolved to provide T-shirt, Shorts, Cap, TA, Good nutritious food such as milk, egg, fruits and quality dinner.
 6. It was resolved to conduct one month Residential Coaching Camp at KSLU for the Student identified by the Physical Education Director from various Law Colleges of KSLU.
