### NOTIFICATION

In exercise of the powers conferred under Sec. 47 read with Sec. 44 & 46 of the Karnataka State Law University Act, 2009 (Karnataka Act No : 11 of 2009), the Syndicate of Karnataka State Law University hereby makes the following Statute, namely :-

#### **1. TITLE AND COMMENCEMENT**

(a) This statute may be called "Statute Relating to the Meeting, Powers and Functions of the Faculties."

(b) This statute shall come into effect from the date of assent of the Chancellor, i. e. - 9.9.2009

#### **2. MEETINGS**

(a) The Faculties shall meet ordinarily once a year or at such times as are fixed by the Vice-Chancellor or on the written requisition of the Dean with the previous permission of the Vice-Chancellor on the written requisition of 1/3<sup>rd</sup> of its members entitled to be present at the meeting of the Faculty.

(b) During the temporary absence of the Dean, the senior most professor who is a member of the Faculty may be appointed as Chairman by the Vice-Chancellor.

#### **3. QUORUM**

The quorum for a meeting of a Faculty shall be one-third of the number of members entitled to be present at the meeting.

#### **4. NOTICE OF RESOLUTIONS**

A member of a Faculty may bring before the meeting of the Faculty any matter within its cognizance by giving written notice of the same to the Dean, who shall, subject to the provisions of Statutes, request the Registrar to include such matters in the agenda of the next meeting of the Faculty.

#### **5. NOTICE OF MEETING AND AGENDA**

(a) Notice of a meeting of a Faculty shall be sent to each member by the Registrar, under the direction of the Vice-chancellor, stating the date, time and place of the meeting and also showing the business to be brought before the meeting.

(b) The period of notice shall ordinarily be fifteen days unless the Vice-Chancellor, for reasons of urgency, fixes a shorter period. No item of business which is not entered on the agenda paper of a meeting of a Faculty shall be considered at the meeting;

(c) The Dean may bring any matter before the meeting without the same being included in the agenda paper with the previous approval of the Vice-Chancellor.

(d) The Dean, may, at his discretion, remit any matter referred to the Faculty to a Board of Studies before placing it in a meeting of the Faculty.

## 6. POWERS AND FUNCTIONS

The Powers and Functions of the Faculty shall be-

- i) to consider and report on matters referred to it by any of the Authorities of the University;
- ii) to refer any matter to a Board of Studies comprised within the Faculty for consideration and report;
- iii) to consider and report on any recommendation referred to it by a Board of Studies before it is referred to the Academic Council;
- iv) to make suggestions or recommendations to the Syndicate and the Academic Council regarding the organization of teaching, training, research and examinations in the subjects comprised in the Faculty.

## 7. JOINT MEETINGS


The Vice-Chancellor may convene joint meetings of two or more Faculties for the purpose of considering any matter common to them and shall preside over such meetings and in his absence the senior-most Dean shall preside over the meeting.

## 8. REPEAL AND SAVINGS CLAUSE

(a) Any Statute existing hereinbefore relating to the Meeting Powers and Functions of the Faculties stands repealed.

(b) Any action, decision or direction taken or directed by the University under any Statute in force at any time earlier than this Statute coming into force, shall be valid, binding on the institutions and remain in force notwithstanding anything contained in this Statute.
