### NOTIFICATION

In exercise of the powers conferred under Sec. 47 read with Sec. <sup>30(i) & (xiv)</sup> of the Karnataka State Law University Act, 2009 (Karnataka Act No : 11 of 2009), the Syndicate of Karnataka State Law University hereby makes the following Statute, namely :-

#### **1. TITLE AND COMMENCEMENT**

(a) This statute shall be called "Statute Governing the Powers and Functions of the Librarian".

(b) This statute shall come into force from the date of assent of the Chancellor, *ie 9.9.20*

#### **2. APPOINTMENT AND TENURE**

The Librarian shall be the whole time officer of the University and shall be appointed by the Syndicate on the recommendation of Board of Appointment constituted under sub-section (1) of Section 68 of Karnataka State Law University Act, 2009.

(b) Terms & Conditions of service and emoluments of the Librarian shall be such as applicable to Professor (UGC).

#### **3. POWERS AND FUNCTIONS**

(a) The Librarian is the executive officer managing the affairs of the Library and overall in-charge of various sections of the library, viz. acquisition, books, journals, technical, maintenance, circulation, digital library, SC/ST book bank, information networking and information services.

(b) The Librarian shall frame the rules and regulations of the library activities and services for the smooth functioning of the library in meeting the required information and other needs of the user community.

(c) The Librarian shall develop the need based information resources of the library, its organization, maintenance and dissemination of information subject to the guidelines framed by the UGC, University, INFLIBNET etc., and manage the Library for effective services.

(d) The Librarian shall be an executive member and convener of the University Library Committee and is responsible to formulate policies, finance, organization, planning and control to advise Library Committee.

(e) The Librarian shall formulate the Library Budget for the acquisition of Books, Journals, Non-print information resources, etc based on the recommendations of the Library Committee, Director of KSLU's Law School, and the faculty members of the University and other requirement of the University Library.

(f) The Librarian shall co-ordinate INFLIBNET/UGC-Info-net, Internet and other information networks for resource sharing, document delivery and information transfer.

(g) The Librarian shall organize courses, programmers, seminars, workshops and conduct classes for effective use of Library, information-resources, information services, communication skills, user education and such other programmers for the development of personality of the students, researchers and other users of the Library.

(h) The Librarian shall exercise such other powers and perform such other duties as may be conferred or assigned to him by the Vice-Chancellor in carrying out the university projects/any related work.

**4. REPEAL AND SAVINGS CLAUSE**

(a) Any Statute existing hereinbefore governing the Powers & Functions of the Librarian stands repealed.

Any action, decision or direction taken or directed by the University under any Statute in force at any time earlier than this Statute coming into force, shall be valid, binding on the institutions and remain in force notwithstanding anything contained in this Statute.
