
Sub: Statute relating to the Establishment of KSLU's Institute of Comparative Law and Justice.

STATUTE RELATING TO THE ESTABLISHMENT OF KSLU'S INSTITUTE OF COMPARATIVE LAW AND JUSTICE

(Under Section 5 (xi) read with section 30(i) of the Karnataka State Law University Act, 2009)

Preamble :

Whereas, the Government of Karnataka established the Karnataka State Law University, Hubli as a specialized University to provide quality legal education in Law Colleges in Karnataka.

Whereas, the Karnataka State Law University Hubli, is providing undergraduate, postgraduate and doctoral degree courses in law and various diploma and certificate courses in law. The curricula and pedagogy for these courses is required to be of international standard.

Therefore, it is felt necessary to establish an Institute of Comparative Law and Justice to conduct research in various areas of law to make the study of law comprehensive and socially relevant.

1. Short Title and Commencement

- a. This Statute shall be called as "The Statute Relating to the Establishment of KSLU's Institute of Comparative Law and Justice".
- b. It shall come in to force from the date of it's assent by the Chancellor.

2. Establishment of KSLU's Institute of Comparative Law and Justice

- a. There shall be a KSLU's Institute of Comparative Law and Justice established on the main campus of the University in Navanagar at Hubli.
- b. The Institute shall function in accordance with the provisions of this statute and the Karnataka State Law University Act, 2009.

3. Aims and Objectives

- a. The Institute shall reinvigorate the research in various fields of law.
- b. It shall promote the learning and understanding of various laws to develop legal professional skills among the students.

- c. It shall attempt to reform the curriculum in all the courses of law in KSLU.
- d. In pursuit of the above aims, the institute shall undertake faculty training and indulge in pedagogic and research activities.

4. Functions

In furtherance of the above aims and objectives, the Institute shall undertake the following activities.

- a. Holding of lectures, workshops, debates, conventions, conferences, seminars, talks, symposia, visual exhibition on subjects intended to promote aims and objectives of the Institute.
- b. Printing, publication, circulation or exhibition of bulletins, books, pamphlets, periodicals, papers, brochures or other literature concerning to the activities of the Institute or embodying the results of its activities or other topics of interest.
- c. Production of reading material for the law students in the domain of various law subjects in Kannada.
- d. To encourage Associations and Organizations in India with similar objectives as that of the Institute, to co-ordinate their activities with the Institute and to federate together and co-operate with one another by establishing closer communication and exchange of views and ideas.
- e. To accept any endowment from State and Central Governments, grants from education and other corporate institutions both within India and abroad for realizing the objectives of the Institute.
- f. To do all such other lawful things as are incidental or conducive to the attainment of the above objectives or any of them.

5. Governing Council

- a. The Governing Council shall consist of :
 - i. The Vice Chancellor as the Chairman (Ex-Officio).
 - ii. The Principal Secretary, Law, Justice and Human Rights or his nominee not below the rank of Additional Secretary to the Government (Ex-Officio).
 - iii. The Director of the Institute as the Convener (Ex-Officio).
 - iv. Deans of Faculties in Law, Social Sciences and Humanities as members.
 - v. Two eminent scholars in law from abroad (nominated by the Syndicate for a period of three years).

- vi. One representative of the Syndicate elected from amongst themselves.
 - vii. One representative of the Academic Council elected from amongst themselves.
 - viii. Provided that, the tenure of the Syndicate member and the Academic Council member as members of Governing Council shall be co-terminus with their membership as Syndicate member and Academic Council member respectively.
 - ix. The Governing Council may co-opt maximum two additional members.
- b. The Governing Council shall meet at least once in six months.
 - c. The quorum shall be more than fifty percent of the members.
 - d. The proceedings of the Governing Council shall be placed before the Syndicate and other appropriate authorities for approval.

6. Director

- a. The Director shall be of the rank of Professor in Law in the University.
- b. A Professor of Law in the University shall be posted as the Director for a period of three years by the Syndicate.
- c. He shall be eligible to be reposted as the Director of another term of three years.
- d. If no Professor of Law is available, an Associate Professor of Law may be posted as the Director.
- e. He shall be responsible for execution of the decisions of the Governing Council.
- f. He shall be in charge of day today administration of the Institute.
- g. He shall be assisted by such non-teaching staff as assigned to the Institute by the University.

7. Faculty

- a. The Institute shall have such faculty as assigned to it by the University.
- b. The faculty shall perform such research and other academic functions as assigned to it by the appropriate authorities of the University from time to time.

8. International Research Team

- a. The Institute shall build international research team in law by organizing workshops on legal research methods.
- b. The international research team shall undertake research activities in furtherance of realizing the aims and objectives and functions of the Institute.
- c. The members of the research team shall undertake national and international research projects (both minor and major) for realizing the aims and objectives of the Institute.

9. Funds

- a. The Institute shall have such of the funds as assigned to it by the University.
- b. The funds shall be operated by the Director after obtaining due approval of the Governing Council and the Syndicate.
- c. The Director shall submit the annual accounts to the Finance Section under due approval of the Governing Council.

11. Repeal and Savings


- a. All the earlier statutes relating to the establishment of this Institute shall stand repealed immediately after the coming into effect of this Statute.
