Applications are invited from the eligible candidates for admission to the Ph.D. programme in Law at the KSLU's Law School Navanagar, Hubballi, and Research Centre at, SDM Law College, Mangalore under Karnataka State Law University, Navanagar, Hubballi for the academic year 2017-18.

The number of seats available are as under:

Candidates who have passed JRF/ NET/ SLET/ M.Phil. through regular course work or belong to FIP/ QIP programmes are eligible to apply. Foreign students with 55% of marks or equivalent grade in the recognized degree, sponsored by their Embassies/ ICCR and have passed GRE and TOFEL shall also be eligible to apply. In case, the above mentioned category of students are not available or after allotment of the seats to the eligible candidates, if the seats remain vacant, the University shall notify at a later date the number of seats available and the schedule for conducting Ph.D. entrance test.

The prescribed application form may be obtained from the office of the University or can be downloaded from University website www.kslu.ac.in. The duly completed application shall be submitted, along with necessary documents and the bank challan or Demand Draft towards the payment of prescribed fees to the respective Heads of Research Centers on or before 17.10.2017.
